- In Greece, Criminology initiated as an object lesson since 1930, first at Athens University and, in 1932, at Panteios School of Political Sciences
- In our days, Criminology is taught mainly at the Schools of Law and of Sociology, but not as an autonomous University Department
- In-depth knowledge is obtained in the context of the
   Postgraduate Programmes started in the '90s

#### Prerequisites & procedure for doctoral studies

Undergraduate studies (4 years)

Master (1 or 2 years)

Minimum time for the completion of PhD: 3 years

The supervising committee: an academic supervisor and two additional members

At the end of each year: progress report

After its completion: report of the supervising committee

The date for the defense of the thesis before the seven-

member examining committee


#### After her/his viva.....




Number of PhDs candidates:1984-2014 Section of Criminology-Panteion University




#### Number of completed PhDs 1994-2014 Section of Criminology-Panteion University

#### The evolution of scientific interest over the years

- During the first period of '80s (1984–89): vast variety of topics juvenile delinquency, women's criminality, terrorism, drugs, prisons etc.
- The decade of '90s minors, drugs/prisons, corruption
- 2000-2009 corruption and organised crime, intra-family violence, sexual criminality or cyber-bullying
- criminal policy and epistemological issues under a 'critical' perspective/organized crime and drugs/ghettos, fear of crime

## PhDs carrying out in the Department of Media and civilization (University of Athens) -not exhaustive

- The crime & the cinema,
- The criminal representation through police reportage,
- The glossary of prisoners or the images of crime through rempetiko (=the songs of the first decades of 20<sup>th</sup> century, linked with illegalities and drug use)

PhDs carrying out in the Law School of Thessaloniki -not exhaustive -

▶ 2009 and 2010: 2 PhDs have been completed focused on criminal policy

- After 2008: 5 PhDs are pending
- Their topics forensic sciences, financial
   crime, women's criminality and state crime


Evaluation of postgraduate and doctoral criminological programs








#### Profession when they started the MA



#### Professional status of postgraduates of the MA of Criminology, Panteion University (2011)




# Main results from the graduates' interviews regarding the contribution of the acquired Master's degree in their professional career
